The National Association of Teachers of Dancing (NATD), UK Examinations - April 2014

I would like to inform you that the coming NATD examinations will be held between <u>25 April and 28 April 2014</u>. Please note that examination entries must be presented by members of Hong Kong Ballroom Dancing Council (HKBDC), the NATD Hong Kong Representative.

If you intend to enter candidates for the above examinations, please complete and return the following documents required for registration to our San Po Kong Office no later than <u>Monday</u>, 24 February 2014. Please note that the HKEAA will not process incomplete entry forms without the required documents.

- 1. Examination Entry form;
- 2. Summary of Examination Entries;
- 3. Photocopy of Hong Kong Identity Card / Passport / Birth Certificate of each candidate with English name; and
- 4. Crossed Cheque made payable to the 'Hong Kong Examinations and Assessment Authority'.

A. Completion of Entry Forms

- 1. Entry forms should be completed in block capitals with black ink or ball pen and signed by the presenting teacher;
- 2. Entry forms could also be downloaded from the HKEAA website (http://www.hkeaa.edu.hk) or collected at our San Po Kong Office;
- 3. Examination entries must be presented by members of HKBDC. No private candidates are allowed to submit applications themselves. For further information, please visit the Hong Kong NATD website (http://www.natd.hk);
- 4. The name of the candidates should be written or typed in the same order as shown on their Hong Kong Identity Cards / Birth Certificates or passports, and the surname of the candidates should be underlined;
- 5. A photocopy of the Hong Kong Identity Card / Birth Certificate / passport of each student should be sent together with the corresponding entry form to ensure the accuracy of the name to be appeared on the certificate. These photocopies should be submitted in the same order of the names as entered on the entry form, in a separate packet. The HKEAA will destroy the photocopies of identification documents after verification;
- 6. A new entry form for each new day of examinations should be used;
- 7. Sections marked 'For Office Use Only' must be left blank; and
- 8. Subsequent request for amendment to information already submitted via entry forms will be subject to the approval of the HKEAA and the payment of a supplementary fee.

B. Preference on Examination Date(s)

- For Professional grades, candidates will be allocated to the examination date of either 25, 27 or 28 April 2014. For Amateur grades, candidates will be allocated to the examination date of either 26 or 27 April 2014. Candidates are therefore required to make sure that they are available on both dates before submit the application; and
- 2. HKBDC reserves the final decision on candidates' allocation.



C. Examination Schedule

For the request of change of examination schedule, a supplementary fee of HK\$56 per candidate will be charged for a successful application.

D. Examination Studios

- 1. All examinations are held at studios arranged by HKBDC and a studio surcharge will be levied on top of the examination fees; and
- 2. Examination studios available with respect to different examination dates are given as follows:

E. Examination Fees

- 1. Examination fees must be paid to the HKEAA with the entry form. Candidates who fail to attend the examination at the appointed time will forfeit their examination fees.
- 2. Under no circumstances will examination fees be returned, transferred or retained for another examination; and
- 3. If a candidate is absent from the examination because of illness, application for half refund of the examination fees can be made in writing within two weeks from the date of examination upon presentation of original medical certificates issued by registered doctors.

F. Bad Weather Arrangement

If weather conditions are at all doubtful (such as the possible raising of a Typhoon Signal No. 8 or above or the issue of the Rainstorm Red or Black Warning), candidates should listen to the radio or television broadcasting station for examination schedules right up to the time they leave for the examination centre. Under normal circumstances, the Authority's announcement of the postponement/cancellation of an examination will be made approximately two hours before the commencement of the examination. The announcement of closure of schools due to a tropical cyclone or the issue of the Rainstorm Red or Black Warning does not necessarily imply the postponement/cancellation of an examination scheduled to be held on that day. Unless an announcement has been made by the Authority that the examination is postponed/cancelled due to bad weather conditions, candidates must assume that the examination will be conducted as originally scheduled. However, candidates should consider their personal safety first. Once an examination has started, it will continue for the full allotted time unless physical conditions in the examination centre are considered dangerous by the examiner. It is important-that you should inform your students, their parents, etc. of these arrangements in advance.
